Digital Risk Assessment Screening -"Lite Version"

This option includes screening on the day before returning to work, as well as on the day of returning to work.



The digital survey tool enables employees to conduct a self-reported screening to assess their COVID-19 risk and vulnerability before returning to work.



The assessment is delivered through a multi-channel platform including WhatsApp, USSD, and Smart SMS (Web link) allowing all employees to access the tool.



Employees will receive feedback on their risk profile based on the questions that have been answered.



On returning, each employee's temperature will be captured by a company rep/dedicated internal resource on an android device or via web link. Training will be provided.



Management will receive a daily "Return to Work" report of all employees that completed the survey providing information of employees with no risk and employees with risk.



The management of employees with risk / high temperature readings will need to take place as per the company policy.



An up-to-date guideline on the COVID-19 Return to Work as per government directives and the National Institute of Occupational Health will be provided to company management.



On a fee for service basis the identified high-risk employees can get access to a virtual / telephonic consultation to receive medical advice through the Hello Doctor panel of medical doctors.

This option is valid for 30 days and will allow employees to conduct the self-risk assessment on a weekly basis.

On-site Return to Work Screening – "Comprehensive Version"

This option includes the digital risk assessment screening (Lite Version), as well as dedicated health professional that will manage the return to work screening on-site.



The digital risk assessment screening is delivered through a multi-channel platform including WhatsApp, USSD, and Smart SMS (Web link) allowing all employees to access the tool.



Health Care professional from Momentum
Wellness will be on-site to conduct screening for symptoms of COVID-19, follow the company's policy on the referrals of high risk cases, etc.



On the day of return to work temperatures of all employees can be captured on an android device or via web link.



Management will receive a daily "Return to Work" report of all employees that completed the survey providing information of employees with no risk, high risks and temperatures captured.



The management of employees WITH RISK / HIGH TEMPERATURE READINGS will need to take place as per the company policy.



An up to date guideline on the COVID-19 Return to Work as per government directives and the National Institute of Occupational Health will be provided to the company management.



On a fee-for-service basis the identified high-risk employees can get access to a virtual consultation to receive medical advice through the Hello Doctor panel of medical doctors.

This option will include the deployment of a health care professional on-site and the infrared thermometer used for the temperature screenings.
